7. Cooperative Grazing Agreement-Winnebago River Corridor

Commission approval is requested for a Cooperative Grazing Agreement with Winnebago County Conservation Board, Worth County Conservation Board, and the U.S. Fish and Wildlife Service for properties located within the Winnebago River Corridor in Winnebago and Worth counties.

Location: This Cooperative Grazing Agreement includes the following properties:

- **Brights Lake Wildlife Management Area** (IDNR; 520 acres) is located approximately 5 miles northeast of Lake Mills in Worth County.
- **Christianson-Taylor Wildlife Management Area** (Worth CCB; 326 acres) is located approximately 3 miles west and 3 miles north of Northwood in Worth County.
- Hogsback Wildlife Area Annex (Winnebago CCB; 54 acres) is immediately adjacent to Lande River Conservation Area and Hogsback Marsh Wildlife Management Area and is located approximately 2.5 miles northwest of Lake Mills in Winnebago County.
- Hogsback Marsh Waterfowl Production Area (USFWS; 588 acres) is located approximately 5 miles north and 1 mile west of Lake Mills in Winnebago County.
- Hogsback Marsh Wildlife Management Area (IDNR; 671 acres) is located approximately 3 miles north of Lake Mills in Winnebago County.
- Lande River Conservation Area (Winnebago CCB; 422 acres) is located 2.5 miles west and 1.5 miles north of Lake Mills in Winnebago County.
- Lost Cabin Wildlife Management Area (Worth CCB; 142 acres) is located approximately 5 miles east and 3 miles north of Lake Mills in Worth County.
- Northern Prairie Wildlife Management Area (Worth CCB; 40 acres) is located approximately 5 miles northeast of Lake Mills in Worth County and is immediately adjacent to Brights Lake Wildlife Management Area, which is owned and managed by the DNR.
- Winnebago County Home Farm (Winnebago CCB; 568 acres) is located 4 miles south of Lake Mills in Winnebago County.

Purpose: All properties listed above are currently managed by the respective entities for upland and marsh habitats and all are open to public hunting. Many of these areas are reconstructed or restored grasslands currently facing management challenges such as expansion of cool-season grasses (e.g., reed canary grass, smooth brome) and woody encroachment. The goal of this agreement is to apply managed grazing to each property to accomplish specific management goals which include decreasing woody encroachment, decrease exotic cool-season grass expansion, increase native forb diversity, and increase structural heterogeneity.

The entities listed in this agreement have jointly determined that it is in the public interest to cooperatively manage the grazing on the above properties. This Cooperative Grazing

Agreement would allow the entities to implement managed grazing on a scheduled rotation using a single producer (identified through the DNR's Habitat Lease Program) to accomplish specific management goals. Cooperatively managing the grazing on these properties also allows for resting the grazed areas to allow vegetation to recover. This agreement is only for the mutual benefit of cooperatively grazing these acres. The management, care, and responsibility outside of this grazing agreement will remain with each respective entity.

Agreement Term: This Cooperative Grazing Agreement with Winnebago CCB, Worth CCB, and U.S. Fish and Wildlife Service is for 10 years.







Amount: Not to exceed \$200,000.00 Dates: October 15, 2024 to October 15, 2026 Funding Source(s): General Fund (State Forest Nursery Sales)

Amendment 3 Purpose: The purpose of the Contract Amendment is to add money to the Original Contract to complete the Original Tasks for an additional two years at the State Forest Nursery.

Original Contract Purpose: This contract created a partnership that allowed ISU students to assist in forestry production aspects at the DNR's State Forest Nursery (SFN) and provided them with experiential learning opportunities. Through work experience, these students had the opportunity to assist with nearly all aspects of the nursery operation, from lifting and grading seedlings to storage and distribution. In addition, students learned to identify, collect, and plant seeds as well as performed seedling maintenance and care.

The SFN, over the years, has explored economical options to assist with the labor and skill needed to operate the nursery. In 2020, as a pilot, the SFN hired ISU students as seasonal workers to assist with nursery operations. The pilot was successful and cultivated student and University interest. This partnership has provided a stable labor resource for the nursery and created a work experience for the students. ISU will promote and provide administration oversight for the students participating in the program. The DNR will provide instruction for the work being performed and oversight and coordination for the approximately 400 man-hours per week anticipated for the assigned work. Tasks in this contract include:

- Collection, harvest and grading of tree seedling stock: ISU will assist with all aspects of tree seedling identification, harvest, collection and grading of seedling stock for storage, stratification and distribution.
- Propagation, planting, locating of seed sources, collection of tree seeds: ISU will conduct activities associated with collection of seed stock, propagation, location of rare species, development of methods for new tree species production, maintenance and production of seedlings.
- Collection of Data: ISU will collect and document data on seed collection, processing, propagation, distribution and methodologies for submission to Iowa DNR.

The DNR will utilize the information gathered and analyzed in this contract to improve processes for tree seedling production, harvest, collection, grading, and to evaluate efficacies of different methods and standards used in tree seedling propagation.

The open pavilion with a large stone fireplace was constructed in the 1950's and is a popular place for picnics and social events. This pavilion has 17 wood columns which have deteriorated/rotted at the base and in need of repair. The concrete floor has cracked and settled causing tripping hazards. This project will cut off approximately 12" of the rotted wood columns and new concrete footings will be constructed along with a new concrete floor. Also, an ADA accessible parking space and a concrete sidewalk is being included with the project.


16.2 Red Rock Wildlife Management Area, Coal Creek Wetland Restoration – Warren County

The Department requests Commission approval of the following construction project:

Project Summary: Red Rock Wildlife Management Area is located around Red Rock Lake, near Knoxville. Red Rock WMA consists of over 32,000 acres of lake, marsh, timber, upland, and grass habitat. Game species in the area include deer, squirrel, pheasant, waterfowl, and dove.

This project is located in the Des Moines River floodplain, and is within the flood easement of Red Rock Lake. This project will add approximately 600 acres of critical habitat for migrating waterfowl and shorebirds by constructing a 2.1-mile long earthen dike with a 200-ft wide auxiliary spillway. Water levels will be controlled by a steel water control structure placed across Coal Creek.

16.3 Hales Slough WMA, Pavement Preservation – Dickinson County

The Department requests Commission approval of the following construction project:

Project Summary: Hales Slough WMA approximately 4 miles NE of Spirit lake. The 527-acre marsh and upland area provides habitat for pheasants and numerous species of waterfowl. The single road access to the area offers two boat ramps on Big Spirit Lake.

The existing culverts are rusted out. The portion of roadway above the culverts has settled due to the degradation of the existing culverts. New RCP (Reinforced Concrete Pipe) culverts will be installed to prevent this type of failure in the future. The centerline joint has deteriorated on some sections of the roadway. These bad areas will be removed and replaced. A bitumen fog seal will be applied to the entire roadway to slow the oxidation of the asphalt binder, and extend the life to the HMA pavement.

16.4 Elk Rock State Park, Pavement Preservation – Marion County

The Department requests Commission approval of the following construction project:

Project Summary: Elk Rock State Park is located on Lake Red Rock which is Iowa's largest lake with over 15,000 acres of water. Elk Rock State Park consists of 800 acres along the reservoir. Park facilities include two campgrounds (equestrian and non-equestrian) with 87 camp sites, a four-lane boat ramp, and multi-purpose trails.

The existing paved roadways were constructed in the early 1970s and 1980s. Age and use has led to pavement oxidation, rutting, random and thermal cracking on the asphalt roads and washboards, potholes, and high shoulders on the gravel roads. Pavement preservation and maintenance items include the following: replacing



culverts, patching, overlaying, crack cleaning/sealing and fog sealing 3.3 miles of asphalt pavement of varying widths and blading/shaping and placing rock on gravel roads and shoulders.

17.1 Chapter 17 Lease Renewal — Randy & Betsy Olson – Dickinson County

Natural Resource Commission is requested to approve the renewal of Chapter 17 Lease Number 44-R with Randy & Betsy Olson.

Location: The areas are four feet wide by sixteen feet long and an area three feet wide by twenty-eight feet long located adjacent to Lot 18, Block 35, Blue Water Beach Subdivision in Section 2, Township 99 North, Range 35 West of the 5th P.M., Dickinson County, Iowa.

Site Purpose: The site contains a deck that is attached to the dwelling and stairs that lead down to the lake area.

Lease History: The location has been under lease since 1983.

Lease Fee and Term: The annual fee is \$150 with a condition the fee may be adjusted to comply with adopted administrative rule changes that affect lease fees. The term of the lease will be five years.

17.2 Management Agreement – Silver Lake Access – Dickinson County Conservation Board The Natural Resource Commission is requested to approve the Management Agreement with the Dickinson County Conservation Board for the Silver Lake Access located in Dickinson County.

Location: This property is located on the south shore of Silver Lake in Section 33, Township 100 North, Range 38 West of the 5th P.M. in Dickinson County, Iowa.

Site Purpose: This 10-acre property is used for outdoor recreation, hunting, and lake access.

Management History: This property has been under a management agreement with Dickinson County Conservation Board since 1999. The previous Management agreement expired December 2023.

Management Agreement Term: This standard Management Agreement is with the Dickinson County Conservation Board for 25 years.

This agreement was approved by the Dickinson County Conservation Board on August 12, 2024.

Upper Iowa River WMA, Winneshiek County – Daniel and Elizabeth Boissy


The Natural Resource Commission's approval is requested to purchase a tract of land located in Winneshiek County and is adjacent to Upper Iowa River Wildlife Management Area (WMA).

Property Description: This rectangular shaped property is located seven miles northwest of Decorah in north central Winneshiek County.
