6. Contract with the Iowa Economic Development Authority

Commission approval is requested for a contract with the Iowa Economic Development Authority (IEDA), of Des Moines, Iowa.

Contract Terms

Amount: - 0 -

Dates: October 16, 2023 to August 15, 2025

Contract Purpose: The Department of Natural Resources' (DNR) purpose in entering into this Cooperative Agreement is to meet Iowa Code 303.2 - 2a(1) legal requirements for buildings identified as eligible for listing on the national register of historic sites by entering into a 28E agreement to ensure the proper management, maintenance, and development of the buildings. IEDA's purpose in entering into this Cooperative Agreement is to meet Iowa Code 303.2 - 2a(1) legal requirements by administering the care for historical sites under the authority of the division and entering into a 28E agreement to ensure the proper management, maintenance, and development of the buildings.

The agreement will define mitigation efforts to resolve the adverse effect from demolishing dilapidated buildings at the Cloverwood 4H Camp. The demolition of these buildings will alleviate staff and public health and safety concerns associated with the use of the buildings.

The major components of the agreement include:

- DNR will submit an interpretive display proposal to IEDA that includes information about the history and use of the camp for review and comment.
- DNR will take IEDA recommendations into consideration for final design if any are provided.
- DNR will construct the interpretive display at the parking lot entrance to the Wildlife Management Area.
- DNR will provide IEDA with verification that the interpretive display has been constructed.
- IEDA will review and comment on the DNR provided interpretive display proposal.
- Once the display is constructed, IEDA will provide concurrence that the constructed interpretive display meets the specifics outlined in the 28E agreement.

Selection Process Summary: This agreement is authorized under Iowa Code Chapter 28E.

REAP City Parks and Open Space Grants (FY24)

The Department requests Commission approval of the recommendations from the Project Review and Selection Committee for REAP City Parks and Open Space Grants as directed by Iowa Administrative Code 571, Chapter 33.

Grant Purpose: The City Parks and Open Space account receives 15% of the REAP funds, after initial distributions are made as outlined in Chapter 33, for competitive grants to help cities establish natural areas, encouraging outdoor recreation and resource management. Three categories have been established to assure grants are distributed to all sizes of cities. Projects considered include development of parks, multi-purpose trails (emphasis on connecting existing trails), park shelters, lake or river shoreline restoration, fishing access, and habitat restoration.

Funding Source(s): Resource Enhancement And Protection Fund – City Park and Open Spaces

Grant Funding Available:

Selection Committee Members: As directed by Chapter 33, a review and selection committee consisting of one DNR staff member and three city appointees (Ames, Elkader and Carlisle) and an at-large representative from Iowa Economic Development Authority's Great Places to evaluate and rank project applications.

Summary of Selection Process: As directed by criteria under Chapter 33.40, the selection committee reviewed and scored all applications. Examples of criteria considered include the relationship to relevant regional and statewide programs based on comprehensive plans (i.e. SCORP, County Resource Enhancement Plan, or local, state and federal plans), quality of site for land acquisition projects, environmental benefits, public benefit, and local support.

Recommendation: The committee recommends funding the projects listed in the Project Allocation. In the event that any of the grantees are unable to execute their project, the Department requests authority to offer those funds to the next highest scored projects that meet the grant criteria or return the funds to the grant program for distribution in the next grant cycle.







Yellow River State Forest Paint Creek Unit







Background: Casey Lake is a 39-acre lake in a 748-acre watershed, with most of the watershed located within the 723-acre Hickory Hills Park. The lake was constructed in 1970, coinciding with the overall development of the park. Hickory Hills Park provides recreational opportunities to the public including: camping, cabins, fishing, electric only boating, hunting, scenic grass trails, animal exhibits, and shelters. The park is located in Tama County but is managed by the Black Hawk County Conservation Board (BHCCB).

Casey Lake is currently on the State of Iowa's impaired waters list for algae (high chlorophyll-a concentrations), which has been attributed to high phosphorus levels in the lake. The Iowa DNR's Watershed Improvement Section produced a Total Maximum Daily Load (TMDL) Report in 2012 to identify sources of pollution to Casey Lake and suggested ways of improving water quality with the goal of removing the impairment at the Lake. Since the TMDL was published, BHCCB has worked to improve the watershed, adding four wetlands above the lake. In April 2019, Park staff completed a gully assessment in the park and several erosion issues were identified, which are contributing to siltation in the west end of the Lake. While many of the watershed issues have already been addressed, there remains an opportunity to improve existing Best Management Practices (BMPs) to further reduce nutrient and sediment inputs to the lake. Additionally, in-lake work is needed to reduce internal loading and remove excess sediment from the western portions of the lake.

In 2021, DNR and the Black Hawk CCB hired Shive Hattery, Inc. to evaluate existing watershed BMPs within the park and develop a lake restoration plan for Casey Lake. As a result of this assessment, project partners moved forward with design for watershed and in-lake restoration practices, culminating with permits and final design plans for construction. Additionally, BHCCB worked extensively to reduce erosion in the park through timber stand improvement efforts in areas highlighted in the initial assessment.

Contract Purpose: The purpose of this cooperative agreement is to fund construction of watershed and in-lake restoration practices at Hickory Hills Park (Casey Lake). Restoration practices (see diagrams below) include renovation of four existing watershed ponds in the park and creation of three new in-lake forebays/ponds to capture sediment and nutrients. In-lake restoration practices include 138,831 CY of targeted sediment removal (mechanical dredging), 3,431 LF of shoreline stabilization, new recreational amenities including a stone terrace, upgrades to the outlet infrastructure, and extensive fish habitat improvements.





Project Summary: This project includes maintenance work for 3.5 miles of gravel roads at Red Rock Wildlife Management Area and 0.5 miles of gravel roads at Keomah State Park. 16.3 Tieville Bend, Pump Replacement – Monona County


The Department requests Commission approval of the following construction project:

Project Summary: Tieville Bend Wildlife Management Area is located approximately 3.5 miles west of Onawa, and consists of over 2,000 acres of upland and timber habitat. Games species in the area include deer, turkey, pheasant, waterfowl, rabbit, and dove.

In 2001, the US Army Corps, in partnership with the DNR, restored a large river habitat in the floodplain adjacent to the main Missouri River Channel. Included in this project was the construction of a duplex pumping station for managing waterfowl habitat at Tieville Bend. Recently, the pumps have failed. This project will remove and replace one of the 90 horsepower pumps.



Otter Creek is the 24th-most popular trout stream in Iowa, likely due to the diverse fishery of catchable-stocked Rainbow Trout and an expanding population of wild Brown Trout. Access to the stream is provided by public lands as well as other publicly accessible angler access points.

Purpose: The proposed angler access easement will provide public access for fishing along 1.21 miles of coldwater stream corridor. Otter Creek trout populations have historically been managed with annual catchable-sized Rainbow Trout stockings. The last stocking of fingerling Brown Trout in Otter Creek occurred in 2017. Sampling upstream in 2020 found Brown Trout over 16" in total length, with multiple year classes present. Follow-up sampling is planned to evaluate Brown Trout natural reproduction throughout the watershed. Otter Creek is currently listed as a Category 1 naturally-reproducing stream for Brown Trout. Moving forward, the DNR will manage for wild Brown Trout with no additional fingerling stockings planned. The Rainbow Trout fishery in Otter Creek is dependent on stocking, and catchable-sized stockings are scheduled to continue. This easement not only will allow public access for fishing, but also for DNR to access for fish stocking, fish sampling, riparian corridor improvements, and fish habitat improvements.
