## **DIRECTOR'S REMARKS**

- Deputy Director Alex Moon informed Commissioners of Director Lyon's recent travels in response to the NW lowa flooding events.
- Deputy Director Moon invited Bureau Chief Sherry Arntzen to provide an update regarding the effects of flooding on the Iowa State Parks system throughout the state. Chief Arntzen listed closures of trails, boating ramps, camping sites, cabins, roads, docks, and parking lots that were affected by flooding of various water bodies located near state parks. Properties affected include, but are not limited to, Rock Creek, Mines of Spain, George Wyth, Ledges, Dolliver, Wilson Island, and Lake Manawa State Parks, Fairport Recreation Area, and several state managed properties in the Iowa Great Lakes region. Chief Arntzen responded to

inquiries regarding possible long-term damage, revenue lost due to cancellations and closures, and FEMA qualified damage.

• Deputy Director Moon concluded his remarks by publicly thanking all DNR employees for their natural disaster response work.

## **DIVISION ADMINISTRATOR'S REMARKS**

- Division Administrator Pete Hildreth also recognized DNR staff for their work with flood response throughout the state and noted the long road ahead for affected communities.
- Mr. Hildreth noted that damage assessments for state managed infrastructure is still undetermined and that staff are working hard to gather data as water begins to recede. One area affected included erosion surrounding a pipe near the Spirit Lake Fish Hatchery. Mr. Hildreth committed to providing updates regarding flood damage at future NRC meetings.
- Mr. Hildreth shared that 1/3 of DNR's Conservation Officers were deployed to respond to the flood event in Rock Valley, together rescuing upwards of 250 individuals by boat.
- Mr. Hildreth gave a report on his recent field experiences, including a pair of ride-a-longs with Parks Supervisors and a visit to see the safety operation at the Lake Manawa State Parks fireworks display event.
- Mr. Hildreth concluded his remarks by encouraging Commissioners to attend one of the upcoming Western Iowa
  Deer Initiative meetings, which are geared toward gathering public input on the low deer population in Western
  Iowa.

## SUBRECIPIENT GRANT AGREEMENT WITH THE CITY OF DUBUQUE-USFWS BOATING INFRASTRUCTURE GRANT (BIG)

George Scholten requested Commission approval of a subrecipient grant agreement with the City of Dubuque for a dredging project around the existing transient dock at the Dubuque Marina. Funds for the project are provided by the USFWS Boating Infrastructure Grant.

#### 6. Chapter 23 – Wildlife Habitat Promotion with Local Entities Program Grant Recommendations

The Commission is requested to approve the following grant recommendations pursuant to 571 IAC Chapter 23, Wildlife Habitat Promotion with Local Entities Program Grants.

**Grant Purpose**: In 1979, the Iowa General Assembly passed legislation requiring hunters and trappers to purchase a wildlife habitat stamp. All revenue derived from the sale of habitat stamps are used within the state of Iowa for acquisition of land, leasing of land, obtaining easements from willing sellers for use as wildlife habitats, and for the development and enhancement of wildlife lands and habitat areas. Beginning in 2019, in accordance with Iowa Code 483A.3, a portion of the revenues resulting from the increase in wildlife stamp fees are restricted from use on land acquisition projects. Grant applicants must provide at least 25% cost share for all projects. By Iowa Code, grant applications are reviewed twice a year.

Funding Source(s): Fish and Wildlife Trust Fund Grant Funding Available: \$664,882 (\$182,482 restricted)

Summary of Selection Process: As directed by criteria under 571 IAC Chapter 23, the grant review and selection committee met 7/9/2024 to evaluate and score applications and provide recommendations for the grant awards.

Selection Committee Members: The review and selection committee consisted of five members:

- County Conservation Boards (4)
- DNR Staff (1)

**Number of Applications Received:** 4 (3 additions to existing/new Wildlife Areas and 1 Habitat Development project) **Recommendations**: The committee recommends offering full funding to two of the Wildlife Area applicants (Humboldt and Clinton Counties) with the remaining \$118,600 being offered to Mitchell County. The minimum score for eligible projects is 45, so the habitat development project was not eligible to be funded. Any unused funds will carry forward for use in future projects.

## 7. Easement Conveyance, Winneshiek County – State Historic Preservation Office (SHPO)

The Natural Resource Commission is requested to approve a 50 year conservation easement for the purposes of assuring preservation at Fort Atkinson Historic District in Winneshiek County, Iowa.

**Project Description:** The lowa Department of Natural Resources received a Saving America's Treasures grant through the National Park Service (NPS) for the purpose of stabilizing and rehabilitating structures at Fort Atkinson Historic District. The Saving America's Treasures grant is funded through the Historic Preservation Fund (HPF). The grant deliverables included developing a conditions assessment for each structure, conducting pre-development tests and analysis of site and structures, and the use of federal funds to improve the historic structures in accordance with the Secretary of the Interior's standards. Additionally, the National Historic Preservation Act requires that HPF grantees sign a preservation covenant/easement with SHPO. The term must be for at least 50 years and must be executed by registering the easement with the deed of the property. The grant-funded work at Fort Atkinson is complete and this easement will be submitted to NPS as part of the final reporting documents.

#### 8. Contract with Ducks Unlimited Inc. (Goose Lake)

Commission approval is requested for a contract with Ducks Unlimited, Inc. (DU), of Dexter Michigan.

#### **Contract Terms:**

Amount: Not to exceed \$100,000 Dates: August 9, 2024 – May 9, 2025 Funding Source(s): Federal NAWCA Grant (\$50,000), Lake Restoration Program (\$50,000)

**Contract Purpose** Goose Lake is a 360 acre marsh predominant herbaceous vegetation of cattails, hardstem bulrush, pickerelweed, and water lilies. This wetland system historically naturally had variable water levels. Due to changes in hydrology within the Goose Lake watershed, the water level remains unnaturally high during spring and summer months. This high water prohibits new hydric perennial and annual vegetation as well as degrading existing perennial vegetation. Additionally, due to the changes in hydrology, in particular changes in agricultural drainage, the channels necessary to manage water levels within the marsh to become filled with silt.

This project would clean out silted in channels within the marsh as well as lowering the existing water control structure two feet. These activities will allow staff to control water levels more actively with a goal of maintaining a proportion of the area in open water, a portion in perennial vegetation, and the ability to dewater and attract annual wetland vegetation. This active management will benefit spring and fall migrating waterfowl as well as breeding taking place on the area.

For this contract, DU will complete project management and completion of the construction project. They will provide construction oversight and inspection services.

The DNR will routinely inspect the construction site and keep DU advised of any updates to the project's construction.

#### 9. Contract with Ducks Unlimited Inc. (Pleasant and Lily Lakes)

Commission approval is requested for a contract with Ducks Unlimited, Inc. (DU), of Dexter Michigan.

#### **Contract Terms:**

Amount: Not to exceed \$250,000 Dates: August 9, 2024 – April 30, 2025 Funding Source(s): Federal NAWCA Grant (\$125,000), Lake Restoration Program (\$125,000)

**Contract Purpose:** Pleasant Lake and Lily Lake are 2 shallow lakes that are connected by their hydrology. They are located in Dickinson County, Iowa within the Spring Run PPJV Priority Area, the Spring Run Bird Conservation Area, the West Fork Little Sioux River – Little Sioux River Ducks Unlimited Living Lakes Initiative Emphasis Area, as well as the Spring Run Wildlife Area Important Bird Area.

The Pleasant Lake – Lily Lake Complex is at the north end of the Spring Run Wetland Complex. Pleasant Lake outlets into a marshy channel then inlets into Lily Lake. Lily Lake outlets at the headwaters of Muddy Creek which empties into the Little Sioux River at the north and through a drainage ditch at its south end that flows through numerous marshes in the Spring Run complex, into Lower Gar Lake, and to the Little Sioux River. The majority of Lily Lake is a deep emergent marsh with a wide fringe of temporary and saturated-soil wetland plants.

Due to the altered hydrology in northwest Iowa and southwest MN to improve agricultural production and the interconnectedness of these shallow lakes' hydrology they experience severe bounce. This project would redo the existing outlet structure on Lily Lake and clean out the drainage way between the two lakes. This will allow managers the ability to manage water levels on both lakes independently as well as at the same time depending on the needs.

For this contract, DU will complete project management and completion of the construction project. They will provide construction oversight and inspection services.

The DNR will routinely inspect the construction site and keep DU advised of any updates to the project's construction.

**Contract Purpose:** To partner with Ducks Unlimited, Inc. (DU) to perform engineering and feasibility assessments on shallow lakes and large marshes in the 35 County Prairie Pothole Joint Venture (PPJV) Region of Iowa. This contract continues our partnership with DU under the Living Lakes Initiative Conservation Partnership initiated in 2006.

The primary purpose of the agreement is to improve water quality in large marshes and shallow lakes where monitoring data show poor water quality and a corresponding reduction in wildlife habitat, native fish populations, and associated recreational use. Projects conducted under this agreement focus on renovation of degraded wetland habitats by removing and excluding carp and other rough fish species, establishing functional water control structures, and reestablishing healthy emergent and submerged aquatic plant communities. Previous projects funded under this agreement include Rice Lake, Little Swan Lake, Clemens, Kiowa Marsh, and Black Hawk Lake.

DU's professional bio-engineering staff will provide engineering services that include preliminary survey, engineering design, bid letting, and construction management services for new water control structures and invasive fish passage barriers at a 50% cost-share rate (up to \$250,000) with DNR. Work will be conducted on multiple projects sites; areas included are West Swan Lake, Garlock Slough, and Eagle Lake.

DU tasks include:

- Prepare all project bid specifications, accept or reject all project bids, and be solely responsible for making any contract changes, additional, or deletions as the work progresses.
- Complete survey and engineering designs needed to obtain necessary permits for construction, to develop accurate cost estimates for construction, and to advertise for bids.
- Provide construction management inspection services to confirm that all site developments are completed in a timely manner.

The DNR will:

- Provide up to \$250,000 on a 50% cost share rate for engineering services provided by DU
- Approve final engineering designs, routinely inspect the site when any construction is in progress, and keep DU advised of any desired changes, and additions, or deletions to the project construction.
- Manage the site to provide habitat that is beneficial to migratory birds.

**12.1 Missouri River Wildlife Management Unit, Road Maintenance – Monona County** The Department requests Commission approval of the following construction project:

**Project Summary:** This project consists of work in three wildlife management areas located in Monona County, under the jurisdiction of the Missouri River Wildlife Management Unit. The first area, Middle Decatur Bend WMA, is located seven miles west of Onawa, and is comprised of 349 acres of open water and marsh habitat. The second area, Louisville Bend EMA, is located four miles southwest of Onawa, and is comprised of 995 acres of marsh, timber, and upland habitat. The third area, Loess Hills WMA, is located eight miles northeast of Onawa, and is comprised of 3,119 acres of upland timber and prairie habitat. ADLM was created to provide waste water treatment for and on behalf of Appanoose, Davis, Lucas, and Monroe counties and, in particular, for the many unincorporated and/or unsewered communities that

surround Rathbun Lake. In 2009, the Iowa DNR and ADLM entered into a 28E Agreement that allowed for shared use of the wastewater treatment lagoons built by the state to service Honey Creek Resort. In this 28E, the parties agreed that Iowa DNR would transfer ownership of the facility to ADLM via a sale once ADLM was ready. This patent seeks to complete the 28E agreement. ADLM will assume responsibility for operation and maintenance of the lagoons, and Honey Creek Resort will pay for its wastewater deposited there, just like all other customers.

The Department recommends the sale to ADLM Counties Environmental Public Health as specified in the 28E agreement. This patent will be completed under the authority of Iowa Code section 461A.32(1). This area is highly developed and contains a wastewater treatment lagoon; therefore, it is "undesirable for conservation purposes" consistent with this statute.

Closing costs will be the responsibility of the ADLM Counties Environmental Public Health.

## 14.1 Klingman Etringer WMA, Clayton County – Iowa Natural Heritage Foundation

The Natural Resource Commission's approval is requested to purchase a tract of land located in Clayton County and will create Klingman Etringer Wildlife Management Area (WMA)

Seller: Iowa Natural Heritage Foundation Acreage: 156.77 acres DNR Purchase Price: \$1,020,000 Appraised Value: \$1,097,000

**Property Description:** This irregular-shaped property is located two miles south of Volga in south west Clayton County. This property will create the 156-acre Klingman Etringer WMA. This property has 85.5 acres of CRP and the remainder in timber. The CRP is a well establish quality reconstructed prairie that currently has a good population of ring-necked pheasant. Additionally, the State Threatened Henslow's Sparrow has been documented on the neighboring property and is expected to be using this property.

Oak is a major component of the timber and future forest management will be heavily directed towards maintain and perpetuating oak where possible. A Forest Wildlife Stewardship Plan will be completed by DNR Foresters and wildlife Biologist.

In addition, the acquisition will protect and enhance approximately 1050 feet of Hewett Creek, located on the west side of the property. Hewett Creek has one of the highest populations of natural reproducing brown trout in the region. No buildings are present on this tract and access is from Sebald Road, a county gravel road.



The Preparation Canyon Unit of Loess Hills State Forest (LHSF) experienced a catastrophic wildfire on April 13, 2023 known now as the Jones Creek Wildfire. Several environmental factors including; long-term drought, low relative humidity, high temperature and high sustained wind speeds combined to create wildfire conditions that led to large scale catastrophic damage and mortality of our trees. A total of 2,402 acres of LHSF were impacted by this wildfire. After a thorough inventory of the forested resources impacted, staff determined that a total of 568.3 acres of forest sustained catastrophic damage from this event. From public safety and ecological standpoints, the best course of action for managing these acres was determined to be tree removal which can be accomplished through salvaging economically valuable timber through timber sales and hiring a contractor to remove trees that have no economic value. Staff are in the process of marking and marketing the salvageable material through timber sales which will account for 217.2 acres total. The remaining 351.1 acres of deciduous and eastern red cedar trees will be removed using a contractor.

In this service contract, the contractor will complete 351.1 acres of tree, shrub and vine clearing as specified in the Request for Proposal by removing the dead and dying trees through approved methods and piling the material in approved locations.

Contract Tasks Include:

- Task 1: Contractor must clear all woody material greater than 1" in diameter on the large end from 249 acres. To prevent adverse soil impacts and erosion, DNR intends to limit equipment travel on slopes greater than 20% grade. Areas where DNR has determined slopes to exceed 20% grade are shown with red shaded polygon on the attached maps.
- **Task 2:** Cut, remove and pile approximately 102 acres of trees, shrubs and vines (here in referred to as "material") damaged during the Jones Creek Wildfire. Clearing areas are designated on the attached map as Cedar in the callout boxes which also included data on the estimated burn severity and estimated acres. The majority of material in these areas is eastern red cedar trees.

**Selection Process Summary:** The Department solicited proposals from targeted small businesses and also published a Request for Proposals (RFP) on the Department of Administrative Services website. Criteria reviewed for this work included the total cost for each specified task. The lowest bid for each task was accepted which both came from the same contractor.
