

## Special 2024 Antlerless Deer Hunt Green Valley State Park

Permitted Weapon: Muzzleloader Only Hunting Dates: November 9 & 10, 2024

## Information (Please read before completing application):

- 1. License applications will be accepted from **September 1 October 31, 2024**. Do not mail the application prior to September 1<sup>st</sup>. Those received after October 31<sup>st</sup> will be rejected.
- 2. 25 applications will be drawn and licenses issued to *lowa residents* for the hunting season and dates indicated above. Each license issued from the drawing will be for one (1) antierless tag. If you are a successful applicant, you will purchase one tag.
- 3. Only one application per individual per envelope will be accepted. (Exception: 1 adult + 1 minor child, 12 years or older. The child must have completed a Hunter Education Course to participate in this special hunt.)
- 4. The license fee of \$28.50 (check payable to Union County Recorder) must be paid at time of this application. If you have already purchased an antierless tag for \$28.50 for other deer hunting, only enclose \$15.00 for the Green Valley Hunt. The fee of successful applicants is non-refundable. Fee of unsuccessful applicants will be returned.
- 5. Harvest is restricted to antlerless deer only.
- 6. Only persons with a special Green Valley gun deer license will be permitted in the State Park during the above dates. A youth hunter age 15 and under may have an adult mentor with them if the mentor has a valid hunting license and has paid the habitat fee, if the adult is normally required to have them to hunt. Only one youth hunter may accompany each adult mentor. The mentor is not required to purchase deer tags, thus, the mentor may not harvest a deer.
- 7. Successful applicants will be notified by telephone or e-mail; and are required to attend a one hour safety and orientation meeting at the Park Office prior to being issued a special Green Valley Muzzleloader Only deer license. The meeting will be on <a href="Friday">Friday</a>, November 8 at 7:00pm. Proper identification will be required for admittance to the meeting. We will ask to see a valid lowa Hunting license.
