\*\*I understand that providing false information on this application will render my application and therefore license invalid and that I may be subject to fines and imprisonment for making a false entry in a public record in violation of Iowa Code 714.8(4), and for hunting, fishing, or trapping without a valid license in violation of Iowa Code 483A.

By signing below, I acknowledge and understand the rules and regulations regarding having this permit and realize that:

- 1. A State Conservation Officer may inspect me at any reasonable time. The Iowa falconry laws can be found in Iowa Code Chapter 481A and Iowa Administrative Code Chapter 101 & 102 and the residency laws in Iowa Code Chapter 483A and Iowa Administrative Code Chapter 15.
2. Raptors legally trapped by nonresidents must be marked with an Iowa marker band provided by the department. No raptor shall be transported from Iowa without first having had the Iowa marker band attached. Permittees may, with written permission from the department provide their own marker band issued by their state of residency. Permittees who provide their own marker band shall place the band on the raptor immediately upon capture and must notify the department within five days of the capture and of the corresponding marker band number. Notification may be sent to the State Falconry Coordinator: Karmin Klingenberg at Karmin.Klingenberg@dnr.iowa.gov.
3. All nonresident raptor trapping permits shall be valid for a period not to exceed 60 consecutive days, beginning on the date of issuance.
4. No nestlings or raptor eggs may be taken. First year (passage)birds may be taken only from September 1 through January 31.
5. The raptor trapping permit shall be carried by the permittee while in the act of trapping and the transportation of any subsequently trapped raptor.
