It WILL NOT appear on your license.		
QUALIFICATIONS:		
The Department of Natural Resources will issue an annual fishing or combination hunting and fishing license to a resident of Iowa who served in the armed forces of the United States on active federal service (other than training) in accordance with Iowa Code 35.1. To qualify, the law requires that the veteran has served on federal active duty and is also a current resident of Iowa and has met our qualifications of residency, including being a resident of Iowa for at least 90 days prior to applying for this license.
