#### **INSTRUCTIONS:**

- 1) This form is to be used for confinement feeding operations that are required to submit a manure management plan, but do not need a construction permit. This fee form with appropriate fees are to accompany an **original** (first-time submittal) MMP for new construction, expansions, and modifications.
- 2) To calculate the **Animal Unit Capacity (AUC)** of the operation, multiply the maximum number of each animal species confined at one time by the appropriate factor indicated below, then add all animal units together:

For example if you are expanding from 600 AU to a total AUC of 800 AU of swine, and had previously paid your fee for the existing 600 AU, enter 200 AU and multiply by the fee of \$ 0.10 per animal unit for a total of \$ 20.00.

3) Multiply the **Animal Units** by the **Fee per Animal Unit** and write this fee in the last column.


